She received the Emily Dickinson Prize for Poetry in 2003 and has been a finalist for the CBC Literary Prize in Poetry. She is a professor of English and Creative Writing at York University.

Brenda Faye McGadney is associate professor and Chair of the Social Work program, Siena Heights University, Adrian, MI. Her current research interests include investigating the implications of foster mothering for the state, health and social needs of older immigrants, caregivers' motivation for institutionalizing older Caribbean Canadians, racialization and expression of whiteness in Canadian social policy and the recreation of racism in the Canadian Human Rights Tribunal adjudication process.

She is editor and author of 19 books on motherhood including most recently *21st Century Motherhood: Experience, Identity, Policy, Agency* (2010); *The 21st Century Motherhood Movement: Mothers Speak Out on Why We Need to Change the World and How to Do It* (2011); *Academic Motherhood in a Post Second Wave Context: Challenges, Strategies, Possibilities* with Lynn O'Brien-Hallstein (2012); and *What do Mothers Need: Motherhood Activists and Scholars Speak on Maternal Empowerment for the 21st Century* (2012). She is editor of the first encyclopedia on Motherhood (2010). In 2010, she was the recipient of the CAUT Sarah Shorten Award for outstanding achievements in the promotion of the advancement of women in Canadian universities and colleges. She is currently completing a monograph on Academic Motherhood and beginning a study on the Slut Walk Movement. She is twice the recipient (1998, 2009) of York University's "Professor of the Year Award" for teaching excellence. She is the proud mama of three fabulous and feminist adult children.

Abigail Palko is the Director of Undergraduate Studies for the Gender Studies Program at the University of Notre Dame, as well as an Affiliate Faculty member of the Department of Africana Studies and Fellow of the Keough-Naughton Institute for Irish Studies. She holds a Ph.D. in Literature with a minor in Gender Studies, and her research focuses on twentieth-century Irish and Caribbean women novelists, with particular attention to their contestations of motherhood as institution and postcolonial questionings of heteronormative sexuality. Hallie Palladino researches and writes about cultural trends in parenting. She is a contributor to the forthcoming books *Stay-at-Home Mothers: An International Perspective* and *Intensive Mothering: The Cultural Contradictions of Modern Motherhood* (both from Demeter Press). She lives in Chicago with her husband and their two young children.

Ruth Panofsky is Book Review Editor of the *Journal of the Motherhood Initiative*. She is Professor of English at Ryerson University in Toronto where she specializes in Canadian literature and culture. Her most recent scholarly books are *The Literary Legacy of the Macmillan Company of Canada: Making Books and Mapping Culture* (2012) and *At Odds in the World: Essays on Jewish Canadian Women Writers* (2008). Her volume of poems, *Laike and Nabum: A Poem in Two Voices*, received the 2008 Helen and Stan Vine Canadian Jewish Book Award for Poetry.

Joanna Radbord is a lesbian feminist mother and a lawyer. Her practice focuses on family law and gay and lesbian equality rights, and she is particularly interested in the legal regulation of lesbian mothering. Joanna was involved with *M. v. H.*, a Supreme Court of Canada decision resulting in the recognition of same-sex relationships in dozens of federal and provincial statutes. She was counsel to a lesbian father in *Forrester v. Saliba*, which states that transsexuality is irrelevant to a child's best interests. She has acted for the Women's Legal Education and Action Fund in cases involving the feminization of poverty, particularly the spousal support variation case Boston and the retroactive child support case DBS. She was co-counsel to

the Ontario and Quebec same-sex couples who won the freedom to marry in Halpern and on the Reference re Same-Sex Marriage before the Supreme Court. Joanna also appeared as counsel in Rutherford, achieving immediate legal recognition for lesbian mothers, and represented the Rutherford families as intervener counsel in *A.A. v. B.B. v. C.C.*, the case allowing recognition of three parents in law.

Christine M. Rohde is an Assistant Professor in Dance in the Theatre and Dance Department at the State University of New York at Potsdam. She graduated with a MFA in Dance from the University of Colorado at Boulder, with a secondary emphasis in Alexander Technique. She is a teacher, choreographer, and performing artist whose work has reached national and international stages. She is interested in research that involves the body and mind, and views the body as a text in motion.

Brooke Richardson is interested in the representation and conceptualization of childcare through discourse. She is currently involved with several projects examining the role of discourse in the Canadian childcare policy making process. In addition to being a mother of three, Brooke is an Early Childhood Studies Instructor and Ph.D. candidate in Policy Studies at Ryerson University.
